By not having our Khronicle for the past year has made us keenly aware of its importance in our organization. Thanks again Noble Allan for reviving our old friend.

With 2015 coming to an end and the anticipation of a New Year about to open up before us we reflect on the past months and wonder what the immediate days ahead will bring. This human phenomena of looking forward and backward is not new. Sospital Report



Shriners International opened their first Shriners Hospital for Children on September 16, 1922, Shriners Hospitals for Children have shared their love with over 1.1 Million Children. Acceptance into the Shrine Hospital System is based solely on a child's medical needs. If in the opinion of our physicians, there is a reasonable possibility they can benefit from the specialized services, a child up to age 18 is eligible for admission without regard to race, colour, creed, gender, sect, disability or national origin.

The Shriners Hospitals for Children System has grown to 22 hospitals and is one of the largest sub-specialty health care systems in the world. Our Hospital System treats thousands of children each year. The staff at our 22 hospitals is dedicated to improving the lives of children by providing pediatric specialty care, conducting innovative research and offering outstanding teaching programs for medical professionals. For clinics, the hospitals have the "Whole Team" approach, making it easier for children with multiple conditions, and their families, to have the complete scope of care in one location at one time and to have an open discussion on what the future holds, even down to planning surgery. So surgery may be delayed in order that a child may go to the prom or to take their finals. In this way our staff deliver cutting edge treatment in a compassionate, family centered environment that helps heal children inside as well as outside.

At Shriners Hospitals for Children care is provided to children with orthopaedic conditions, burn and spinal cord injuries, as well as cleft lip and palate regardless of a family's income, ability to pay, insurance coverage or insurance status. Within these broad service lines many types of specialized services are available. As an example some locations offer reconstructive plastic surgery, while others provide treatment for craniofacial abnormalities or care for sports injuries.

The Shriners Hospital for Children - Canada is the second busiest hospital of the 22 Shriners' hospitals, with close to 17,000 outpatient visits to the ambulatory care clinic in a year. With the new hospital in operation it is expected that number will jump to 25,000 visits. Conditions treated at SHC-Canada include spina bifida, osteogenesis imperfecta , with procedures undertaken such as botox injections (this is used in part as a pain management tool), prosthetics and orthotics, rhizotomy, ilizarov and more. However this facility does not treat burns or spinal injury as other hospitals in the network host those specialties.



The Annual Budget for Khartum Shrine's Patient Transportation Fund is \$230,000.00. In 2014 Khartum spent \$290,800.00 (including an air ambulance flight at a

cost of \$14,500.00) for the 250 patient visits sponsored by Khartum Shriners. These patient visits involved 95 different children (18 new) from Manitoba and Northwest Ontario. Patient visits varied from a child with one visit to children with eleven visits, and stays from half a day to 68 days. The majority of our children are treated at Twin Cities Hospital (68.4%) and the SHC-Canada (24.8%). We also sponsored one child for four visits to the Boston Hospital, four Children for twelve visits to the Chicago Hospital and made use of the Satellite Clinic once. Of the 250 patient visits 36% were NW Ontario, 44% were Winnipeg and immediate area and 20% were from the rural Manitoba Shrine Clubs.

As of the end of October, Khartum Shriners have sponsored 198 patient visits (10 new children) at a cost of approximately \$155,700.00. The visits for 2015 have been: Thunder Bay/Minneapolis -61, (1 new); Thunder Bay/Montreal - 2; Dryden SC/St Louis - 3 (1 new); Lake of the Woods/Montreal - 9 (1 new); Winnipeg/Montreal - 19 (4 new); Winnipeg/Minneapolis - 62 (1 new); Winnipeg/Chicago - 6; Selkirk Shrine Club/Montreal - 1, (1 new); Selkirk Shrine Club/Minneapolis - 11; Brandon SC/Montreal - 5 (1 new); Brandon SC/Minneapolis 5; Pembina Valley SC/Montreal - 3; Pembina Valley SC/Boston - 5; Dauphin SC/Montreal - 2; and North of 53/Montreal - 1. In addition we have one patient from Thunder Bay in Toronto Sick Children's for about 3 months.

The funding for Khartum patient transportation is made possible by funds raised through the Circus Daddy/ Mom program, aluminum recycling (cans and license plates), donations and bequests made to our patient transportation fund and by the support of the Clubs, Units, Nobles and Ladies of Khartum. As well donations of West Jet vouchers and Aeroplan miles, help to offset our travel costs. Imperial bylaws dictate that any funding designated to Patient Transportation or Shriners Hospital of Children cannot be used for the operations of any the Shrine Center or used to offset Shrine Centers costs. The patient transportation fund is a charity and in essence is Hospital funds.

In 2013, a public fundraising campaign for the new SHC - Canada called Exceptional Care for Exceptional Kids was kicked off, seeking financial support for the new Canadian Hospital. The new SHC - Canada was dedicated on August 20 of this year and officially opened the week of September 28 when the transfer was made

from Cedar Ave to the new Hospital at 1003 Boui Decarie at the McGill Campus, Glen Yards site. Our new SHC-Canada is now part of an extensive medical facility; however we are still a Shrine Hospital for Children. The goal of the fundraising campaign was to raise \$130 Million. As of the end of August, 2015, \$123.3 Million or 94.8% of that objective has been reached. At the dedication, Illustrious Sir Brian Terin and other members in attendance, presented a check to Imperial Sir Jerry Gantt, Imperial Potentate, and the Chairman of the Board for the Canadian Hospital, Illustrious Geno Beretta, with a check in the amount of \$29,900.00 from the Gala Dinner held in June.

For over 90 years, children from Canada, the U.S. and from around the world have benefited from Shriners Hospitals for Children. Above and beyond the world-class care, our Children have found a home away from home, a place where their disabilities do not define who they are, but are merely a stepping stone to becoming the most productive, active and autonomous adults possible. Each and every Shriner is a part owner of this great system.

This is what it is all about, Shriners helping kids have a better quality of life, putting smiles on their faces and giving them the greatest gift of all - Hope.

Donor Relations

anadians are a generous lot with a strong sense of social responsibility. About 24 million, or more than 82% of the population aged 15 and older, made a charitable donation in 2013, adding up to \$12.8 billion. At the same time, almost 13 million or close to 45% of Canadians in this age group put in a collective 2 billion hours of volunteer time toward a good cause.

But here's a curious fact: while an overwhelming majority of Canadians gave money to a charity or non-profit organization in 2013, only 5.6 million or about 22% of tax filers claimed a charitable donation on their tax returns. For the 18 million Canadians who didn't tell Canada Revenue Agency about their financial philanthropy, this omission may translate directly into missed tax savings.

Back to Basics: Gifts and Donations 101

Understanding the tax rules around gifts and donations is the first step toward ensuring you don't miss out on opportunities to optimize your tax position. As a basic general rule, money or certain gifts made to qualified organizations can be claimed toward a federal and provincial or territorial tax credit on your income tax return. Because this tax credit is non-refundable, it can be used to reduce a tax liability but won't trigger a refund if you don't owe any taxes.

You can claim gift amounts of up to 75% of your total income, and up to 100% in the year of death. Keep in mind that the value of any "advantages" you derive from your donation such as free products or tickets to

an event must be deducted from your claim.

Crunching the Numbers

The amount of your charitable donation tax credit is based on two tax rates: federal and provincial or territorial. These rates are, in turn, classed into two tiers based on the amount of your donation. For the 2014 tax year, gifts of up to \$200 qualify for a 15% federal tax credit while anything above \$200 qualifies for a 29% tax credit. In the same vein, each province and territory applies two tax rates, a lower one for gifts under \$200 and a higher rate for gifts over \$200.

Once you are comfortable and confident about your remaining income-earning years and your retirement-income years, you can begin planning your legacy and contributions to your favourite charity. To crunch your tax credit numbers, use CRA's charitable donation tax credit calculator at http://www.cra-arc.gc.ca/chrts-gvng/dnrs/svngs/clmng1b2-eng.html

First Time's the Charm

If you or your spouse or partner are claiming your first charitable donation for any year after 2007, you get a little extra something called the First Time Donor's Super Credit (FDSC). Applicable to monetary gifts made after March 20, 2013, the FDSC gives you an additional 25% tax credit for donations up to \$1,000. Using the previous example, this super credit adds up to an extra \$250 for a total non-refundable tax credit of \$611.38. If you have not given a donation to Shriners Hospital for Children lately, hopefully this "super credit" lights the fire!

Did You Get a CRA-Qualified Receipt?

There are thousands of Canadian groups and organizations that do good, but not all of them can write you a receipt that will make you eligible for a tax credit. Before donating to a particular charity or institution, check CRA's online listing of organizations authorized to issue official donation receipts at http://www.cra-arc.gc.ca/chrts-gvng/dnrs/rcpts/dntn1-eng.html. In addition to charities and non-profits, organizations such as some amateur athletic associations, low-cost housing corporations and governments may also be qualified to issue receipts eligible for a tax credit.

Tello again Nobles. In this 'new' issue 'transition' and 'life change' are noteworthy keywords.

Noble Glen Thorsteinson, for 10 years the exceptional Editor of the Khartum Kronicle, who enhanced it to a quality publication, retired after the issue of Volume 11, Number 1 in 2014. We thank him most sincerely for his Herculean efforts.

Now we are most pleased to welcome Noble Allan Cantor, a member of our Unit, as the new continuing Editor - a most 'noble' gesture on his part!

Historically the Ritualistic Unit was constituted as the "Ritualistic Divan of Khartum Temple" on June 12, 1963. The first officers were Nobles A.E. 'Al' Ritchie, President; W. R. 'Bill' Irwin, Secretary; and Graeme C. Norman, Ritualistic Director; who was instrumental in preparing the ritualistic presentation, much the same as we know it today, and 'acted' as the first Potentate. The Constitution stated "The primary purpose of the unit shall be to provide ritualistic work of the highest possible standard at Ceremonials of Khartum Temple." The first Ceremonial took place at the Lakehead on September 7, 1963, the second on October 17, 1963, in the Winnipeg Auditorium (now Manitoba Archives), while many patrons were simultaneously enjoying the roller rink below. In 1964, the use of the word "Divan" previously restricted to the Imperial Divan, was removed from the name of the Unit. Then the June 1965 issue of Khartum News was included the first report by "Ritualistic." Thereafter, the Nobles in the Unit were simply called "Ritualistics" until 1968 when the name became the "Ritualistic Unit."

Now again, on October 18, 2015, it was another welcoming Khartum Shrine Ceremonial for the new Nobles with

the Degree Team Cast attired in colorful costumes. This year's Ceremonial was under the direction of Noble Bob James and the caste was as follows:

An Orator, his words beseech, of golden treasures within one's reach: Tolerance, Charity, and Benevolence all, are daily principles 'of best recall'; For adverse actions of stigma and stain, his simple actions are 'please refrain' And for fine fellowship, that nice rite, what is the best way to keep it bright?
